Introduction

Welcome to the Contract Buyer User Guide for the Provision of Hazardous Risk Waste (Irish Public Sector Bodies).

How to use this contract agreement?

- To avail of Hazardous Risk Waste services contract, the Public Sector Organisation (Contracting authority) must complete the Notification to Activate Service Form (Appendix 1) of this document to activate the Contracting Authority participating in this contract and return it to the Contractor (Stericycle)for signing. using the email <u>fdowling@stericycle.com</u>
- To avail of the Hazardous Risk Waste services contract, a Public Sector Organisation must then complete the Setup Form (Appendix 2) and return it to the Contractor (Stericycle) using the email fdowling@stericycle.com
- The Contracting Authority can conduct a Supplementary Request for Quotation (SRFQ) (Appendix 3) for Hazardous Risk Waste services and return it to the Contractor (Stericycle) using the email fdowling@stericycle.com
- In the event that any issue with the services provided is not satisfactorily resolved, the matter may be escalated using to Issues Notification Form (Appendix 4)
- To discuss your requirements, the Contracting Authority can contact the Contractor; Stericycle (Appendix 5 Contractor Personnel Assigned Contract Support and Liaison).

Overview of Requirements

This procurement process is on behalf of the Irish Public Health System (HSE), Organisations funded by the HSE and the Irish Public Sector. The Irish Public Sector client base is comprised of Central Government Departments, Offices and Non-Commercial Agencies and Organisations that have a formal reporting and legal relationship with these departments including; Local Authorities including Town Councils, Regional Assemblies, County Enterprise Boards and Libraries: Third level institutions (Universities, Institutes of Technology); Bodies which are Education and Training Boards (ETBs) and ETB schools, as well as ETBs acting on behalf of schools, groups and clusters of schools and centres and also National primary, post-primary, special and secondary schools; The Security Sector – An Garda Siochána, the Defence Forces and the Irish Prison Service.

The service must be delivered from 02nd April 2019 and will be for a contract period of eight years. The service will reflect and avail of the Best Available Techniques (BAT) criteria to ensure the highest environmental and health and safety standards in support of the EPA's National Hazardous Waste Management Plan 2014-2020. Emphasis to be placed on the Waste Management Hierarchy and energy recovery of treated Hazardous Risk Waste (HRW). The contractor will be responsible for seeking and obtaining from the relevant authorities any information which may be required for the necessary hazardous permit/licencee requirements and will be required to adapt to changing circumstances arising from new practices and evolving policies and statutory legislation and amendments during the period of the contract(s).

The contractor will be required to work to the relevant definitions and categories of healthcare waste in accordance with Annex III of the EU Waste Framework Directive, The EC (Waste Directive) Regulations 2011 S.I. No 126/2011 and the Waste Management Act 1996 as Amended and European Waste Catalogue (EWC) and Hazardous Waste List 2015, as amended from time to time.

Tender Clients are:

- Contracting Authorities in the Irish Health Sector including but not limited to the Health Service Executive (HSE), the Health Information and Quality Authority (HIQA) and HSE / Publically funded agencies delivering health and personal social services funded by more than 50% from Exchequer funds; (a) all service providers to the HSE falling (now or in the future) under (or considered and/or treated by the HSE, in its sole discretion, as falling under) Section 38 of the Health Act 2004 (as amended) (a "Section 38 Body"); (b) all bodies/entities falling (now or in the future) under (or considered and/or treated by the HSE, in its sole discretion, as falling under) Section 39 of the Health Act 2004 (as amended) (a "Section 39 Body"); (c) such services providers', bodies' and/or entities' (under (a) and (b) above) successors, transferees, replacements and/or assigns); and (d) all publicly funded hospitals, all publicly funded community organisations and health agencies.

- An Garda Siochána; and
- Ministers of the Government of Ireland, Central Government Departments, Offices and non-commercial Agencies and Organisations¹ which have a formal reporting and legal relationship to Central Government Departments, including all Local Authorities in Ireland (themselves including regional assemblies, county enterprise boards and library bodies).

Carriage of Dangerous Goods by Road Regulations - ADR Classification

The principal class of substance relevant to healthcare hazardous waste is Class 6.2 – infectious substances. Class 6.2, infectious substances, comprises of those substances known or reasonably expected to contain pathogens which can cause infectious disease in humans or animals. Substances of Class 6.2 are subdivided as follows:
