If the first ranked supplier is unable to provide the required goods, is unavailable to provide the goods within the set time limits or in the event of underperformance, the request to provide the goods will be automatically sent to the next	
	ranked supplier, in descending order.  Mini-competition — Where the Mini-competition method of drawdown is used to call-off the goods, each Framework Member appointed to a Lot will receive a Supplementary Request for Tender ("SRFT") to compete for the contract.
