Contracting authorities which are Third Level Educational Institutions (including Universities, Technological Universities, Institutes of Technology and members of the Education Procurement Service);</li> <li>4. Contracting authorities which are Education and Training Boards (ETBs) and ETB schools, primary, post-primary, special and secondary schools as well as ETBs acting on behalf of schools;</li> <li>5. An Garda Síochána (Police);</li> <li>6. The Irish Prison Service; and</li> <li>7. The Defence Forces.</li> </ol>
