Term & Renewal Options:	The term of the Framework and any contract awarded within the Framework will be for a term of one (1) year with the option to extend for a period or periods of up to twelve (12) months, with a maximum of three (3) such extension or extensions on the same terms and conditions. The Term will not exceed four (4) years in aggregate.
Contracting Authorities who can avail of Framework:	Central Government Departments, Local Authorities, Contracting Authorities in the Health sector, Third Level Education Institutions, Contracting authorities, which are Education and Training Boards (ETBs), and Schools, An Garda Síochána, Irish Prison Service and The Defence Forces.
Method(s) of Drawdown	Mini-Competition/SRFT Call-off Method or Request for Quotation (RFQ) (as appropriate).

### SCOPE & SUPPLIERS

The Framework Agreement is for the supply of Livestock Feed and Fertiliser to eight Teagasc locations and other Public Sector Bodies locations in Munster, Leinster, Ulster and Connaught.

25 Suppliers have been appointed to this Framework.

There are two methods of drawdown from this Framework - Mini-Competition/SRFT Call-off Method or Request for Quotation (RFQ). Each Lot can decide which drawdown method is most appropriate for their Lot.
